# Restaurant, Bar & Tavern Business

#### CLASSES OF BUSINESS

Target classes include small to medium-sized restaurants, bars, taverns, and some nightclubs located in states with ISO Liquor Liability Grades of 0-6. Risks are individually assessed with respect to determining limits and coverages.

## POLICY HIGHLIGHTS

Primary limits up to:

- \$1,000,000 per occurrence / \$2,000,000 aggregate for General Liability
- \$1,000,000 each common cause / \$2,000,000 aggregate Liquor Liability
- Various sublimits up to \$1,000,000 per occurrence / \$2,000,0000 aggregate for Assault and Battery

## FLEXIBLE OPTIONS

- Deductibles and SIRs are available
  - \$5,000 minimum attachment for most risks
  - \$25,000 minimum attachment for nightclubs
- Minimum premiums
  - \$25,000 for most risks
  - \$100,000 minimum premium for nightclubs
